2 Financial management

Iryna wishes to know what the payment deadline is for costs incurred during the project period. Ellen will check the grant agreement to check if there are strict guidelines regarding the deadline for payments after the project is finished.

3 Prolongation request: what is the situation?

Several reminders have been sent to EACEA since the last meeting, unfortunately Geert still hasn't received any answer yet, except stating that they will inform the coordinator soon about the decision made.

Besides the fact that we do not yet have a definite answer on any extension, EACEA has also not yet confirmed that the change of legal entity for NMAU and USUST is ok. This is a pending issue since September 2022.
